## 6 Questions Every Parent Should be Asking about Their Child's IEP

*I had a very special guest on my LiveLifeBig program this month, and we were talking about an issue that's very near and dear to my heart: education. Every parent wants the best education possible for their children, and we live in an age now where a child's education can be specially tailored for them.*

In Virginia, this takes the form of an IEP, or an Individualized Education Program. When executed properly, it can be a godsend for a child who doesn't thrive in the traditional education mold. For a lot of parents, however, the whole IEP process can be confusing and overwhelming. This month, we welcomed Educational Attorney Joan Proper, who shared with us six questions parents should be asking about their child's IEP, but often don't know enough to ask...

### 1 Is the child's diagnosis up to date?

Also called the child's Disability Designation, you have to make sure that the report accurately reflects what the child is going through. It's very common for one learning disability to be part of (or lead to) another. Learning disabilities can sometimes be better understood as part of a "spectrum" of disorders rather than a singular issue.

### 2 Is the IEP actually being implemented?

This is a big one. All your hard work with the school and the child can go to waste if the instructors are not following through with the program. Measurable goals are key. If there are no ways to tell whether the child is progressing, the IEP isn't doing what it was intended to do.

### 3 When is the last time the child had a complete formal evaluation?

This can be done by the school or by a private institution. Everyone thinks they know the child's needs or what the child is going through, but it's a good idea to have a real evaluation done every two or three years. What's their reading level? What math skills can they perform? What's their emotional status? Formal testing is an invaluable measuring stick.

## 6 Questions Every Parent Should be Asking about Their Child's IEP

### 4 Does the IEP provide an accurate Present Level of Performance, including goals?

It's not enough to just say, "This is where the child stands." The best IEPs have goals in place to overcome obstacles. Does your child's IEP have reasonable, measurable, step-by-step goals to determine progress?

### 5 Is my child's behavior interfering with his or her education?

Some behaviors are obvious, like aggression or lashing out in different ways, but other issues like depression or simple non-compliance can be more subtle. Is your child not doing work? Just sitting at her desk and putting her head down? Just because the child isn't getting in trouble doesn't mean that everything is OK.

### 6 What diploma options are there with my child's IEP?

Schools are getting much better at understanding IEPs and making programs that give all children a chance to succeed, but it's an ongoing process. In Virginia, most kids are looking at a Standard Diploma or an Advanced Diploma. The good news is that many children with IEPs still have access to Advanced Diplomas, but it's a question you should be asking from the start.
