

## BGL's Best Bites SUMMERTIME ZUCCHINI CASSEROLE

#### Ingredients:

- Zucchini (5 small)
- Tomatoes (2–3)
- Bulk sausage (1/4 lb)
- Italian seasoning (1 tsp)
- Salt (to taste)
- Grated cheddar cheese (1–2 cups)
- Italian-flavored breadcrumbs (1/2–1 cup)

#### Preparation:

- 1 Preheat oven to 350 degrees
- 2 Slice and layer zucchini about an inch thick in a rectangular casserole dish (five small zucchini for a large casserole)
- 3 Sprinkle with Italian seasoning and salt or your favorite seasoning
- 4 Cut and layer tomatoes on top of zucchini (in off season, I use canned tomatoes, drained)
- 5 Place chunks of raw sausage over tomatoes
- 6 Bake at 350 for about 35 minutes, until zucchini is crisp-tender
- 7 Drain off liquid and top with grated cheddar cheese mixed with Italian-flavored bread crumbs.
- 8 Return to oven until cheese is melted.
