## BGĽs Best Bites EASY OYSTER STUFFING



#### Ingredients:

3 boxes of stuffing mix
2 cans fresh oysters, drained, reserving liquid
3 ribs celery, chopped
1 lg. onion, chopped
1 stick butter
Salt and pepper

#### **Preparation:**

- 1 Saute celery and onion in butter until soft.
- 2 Prepare stuffing mix according to directions on box, substituting reserved oyster liquid and sufficient water to equal required liquid. Season to taste.
- 3 Cut oysters in half and mix in lightly.
- 4 Bake in casserole at 350° covered for 35 minutes; uncover and bake an additional 10 minutes.

#### **RECENT VICTORIES:**

Fairfax County jury awarded a 53-yearold Dumfries, Virginia, man \$311,000 for damages and injuries sustained.

In January of 2012, a 51-year-old man was hit by another driver who was travelling about 55 miles per hour on I-95.

He sustained multiple injuries in the accident, suffered from shoulder and knee pain, as well as a large facial gash among other injuries.

After following up with an orthopedic surgeon, it was determined through MRI that the victim had a large tear of the rotator cuff on his right shoulder and surgery would be needed.

The injured driver had \$40,000 in medical bills and nearly \$60,000 in lost wages.

The jury's verdict of \$311,000 was almost \$100,000 more than the insurance company had offered to settle the case. The jury deliberated about 30 minutes before returning its verdict.

# **Smartest Guy at the Party:** Know the Legal Vocabulary that Most People Don't

# "Statute of Limitations"



November's "Smartest Guy at the Party" vocabulary phrase of the month is "statute of limitations." The statute of limitations is the amount of time you have to file a case in court after an injury. If you got into a car accident 30 years ago, it would be weird to go to court for it today, right? That's why we have a statute of limitations in the American legal system, so that matters are addressed close in time (relatively) to the event itself. Each state follows different statutes.

In the Commonwealth of Virginia, if you've been hurt and you unfortunately need to take legal action against someone, here's how long you have to do it:

- 1 In a **car accident**, you have **two years** from the accident to file a lawsuit.
- 2 Similarly, if you've been injured by a medical professional (what we lawyers call medical malpractice), you have **two years** since the time of the injury to file a lawsuit, but there are exceptions:
  - A child who is injured by malpractice has until his tenth birthday but his parents have only five years to sue for the medical bills. Confused? Call us.
  - If the surgery left a foreign object in the patient, the statute of limitations is longer.

**3** In long-term disability cases, if you're disabled and your **claim has been denied**, you could have as little as **six months or** up to **five years**, depending on whether your claim is governed by state law or the federal ERISA law. Honestly, if your claim has been denied, you need to call us as soon as possible. BenGlassLaw is one of a small group of firms in the entire country who deal with ERISA cases and you may need to move quickly.

So, now you know all about the statute of limitations, and you're free to tell your friends. Hey, we didn't say you'd be the *life* of the party, just that you would be the smartest guy there.
