Northern Virginia Wins Amazon Headquarters Bid

But What Will it Mean for the Region?

After courting cities all around the country in what can be only described as "a season of the Bachelor only an investment banker would enjoy," Amazon has finally made its decision.

New York City and Arlington, Virginia, will host the next two headquarters of the global juggernaut. Specifically, the northern Virginia HQ will be located in a newly branded neighborhood called "National Landing," which is a combination of Crystal City, Pentagon City, and Potomac Yard in Alexandria. It was the cities, not Amazon, which went for the rebrand in an effort to win the bid.

Our region has been doing well economically - the federal government and its related industries provide a base level of jobs in the area that other U.S. cities don't have. We have a highly educated workforce, favorable corporate and tax laws, and we're the home of another Jeff Bezos-owned property, *The Washington Post*.

Amazon touts that it will bring between 25,000 and 50,000 jobs to the area and over \$2.5 billion in investments. Virginia is putting in nearly \$200 million to improve infrastructure, specifically the Metro stations and pedestrian areas around Reagan National Airport.

BGL's Best Bites HOLIDAY BLACK-EYED PEAS



Black-Eved Peas are a New Year's classic in my family, but this approach takes the dish to a whole new level. I started cooking it this way a few years ago, and Googled to see who thought of it first.

Turns out, the French beat me to it: legendary chef Jacques Pepin described this as a "Black-Eyed Peas and Kale Ragout" in the New York Times in February 1991. Enjoy! ______

Ingredients (6 servings)

- 1 lb black-eyed peas (OR four 15-oz cans Glory Southern-Style Black-Eyed Peas)
- 1 lb kale, washed and cut into 2-inch pieces
- 8oz Virginia ham, cut into ³/₄-inch cubes
- 4 cloves garlic, peeled and sliced (2 tablespoons)
- Hot Sauce (to taste)

Directions:

- 1 If using raw black-eyed peas, rinse and start boiling the peas in 6 cups of water. Once they reach a boil, simmer for 45 minutes. Or just get those cans of Glory Black-Eyed Peas (trust me, this is the way to go) and reheat about 10-12 minutes.
- 2 While the black-eyed peas are cooking, sauté the cubed ham with the sliced garlic in a pan over medium-low heat.
- **3** Wash the Kale and chop it. After the ham has been sautéing for 5 minutes, add the kale to the pan with the ham and garlic and cover for 10 minutes (the kale will reduce a lot).
- **4** At serving time, combine the kale mixture with the beans, stir, bring to a boil and simmer together for 8 to 10 minutes. Serve with hot sauce, if desired (I use Frank's).

That's it! Simple, delicions, and perfect for the cozy, winter holidays.

Northern Virginia Wins Amazon Headquarters Bid

With the plan set in stone, it's time to make some predictions for how Amazon HQ2 will impact the region:

1. The traffic is going to get even worse.

If you've lived in this area for any amount of time, you know that the traffic is a godless, nightmarish experience which drains one's soul of its lifeforce. We've combined bumper cars, anger management, and drivers ed. into a chaotic, daily ritual that the founding fathers never intended. 50,000 jobs is great, but the region is already bursting at the seams.

2. Housing prices will skyrocket.

D.C. is not currently experiencing a crisis on the level of San Francisco or New York City – where property prices are so high that minimum wage labor cannot affordably live within two hours of the city - but Amazon HQ2 will move us firmly in that direction. This will not have the same level of impact as Starbucks in Seattle or Ford in Detroit, etc., but Amazon will become a part of D.C.'s image to the rest of the country. Our city is known for politics, museums, government contracting, and the "foodie" scene, but now it will be known for a major online retailer, as well.

As Amazon starts to break ground in the area, we will see whether these predictions are off the mark. At the very least, the region is in for a mountain of financial investment and population growth. Get ready!


