BGL's Best Bites SHARON'S CHICKEN CASSEROLE

Ingredients

- Rotisserie Chicken deboned and shredded
- 1 can cream of chicken soup
 I use the low fat
- 1 can cream of mushroom soup - low fat
- 1 container sour cream low fat or fat free
- 1 box chicken broth or chicken stock
- 1 package egg noodles (No Yolks)
- Pepperidge Farms Herb Stuffing

Directions:

- 1 Shred chicken from bone and set aside.
- 2 Cook ½ to 3/4 of egg noodles according to package instructions using chicken broth or stock instead for ½ of the water.
- **3** Once noodles are done, drain and save liquid.
- **4** In a big bowl, mix all ingredients and about ½ cup of reserved liquid. Put in casserole dish.
- **5** In a separate bowl, melt 2-3 tablespoons of butter. Add stuffing and stir with a fork until well blended. Sprinkle over casserole.
- **6** My family likes the stuffing finer, so I put some in a Ziploc bag, use a rolling pin to make the stuffing finer.
- 7 Bake at 375 for about 30-45 minutes– until top is brown and it is bubbly.

New Telephone Scam on the Rise Targeting the Elderly

According to a recent Bloomberg article, scammers steal about \$37 billion per year from America's elderly. Unfortunately, these scam attempts aren't going to slow down any time soon.

Many of the popular scams from the past decade are still in play. A scammer will tell the elderly person that she has won a sweepstakes, and all she needs to do is wire money to start the process. They continue to string her along until her life savings are depleted. The scammer will commonly tell the person that they need to keep their winnings a secret or they will lose their prize.

The fact that someone could do this to an elderly person is sickening, but we must look evil in the face if we are to understand it, defend against it, and eventually conquer it.

Recently, a new trend has started – hyper-focused attacks where the scammer knows a LOT about the target's life and will sometimes pretend to be a family member of the target. These calls can be quite intimidating, because the scammer is able to recite very specific things about the victim's life which can be used to build trust or cause confusion.

Keep an eye out for these scams, and spend time with your loved ones! The best defenses against these tactics are education and open communication.

WHAT'S ON BEN'S MIND?

- I don't get this whole "Russia interfered in our election" thing! What is it they are claimed to have done? Buy votes? Nope. Hack the electronic voting system? Nope. Blackmail politicians? Nope. It is claimed that they interfered by running ads and other messages ("fake news") on all sorts of social media accounts. Big Whoopie. Most of the stuff on social media is some version of "fake news" anyway. No, that kitty cat did not scratch the burglar's eyes out! America ought to be embarrassed, not by the fact that the Russians were allowed to post (hey, we do advertise our country as a "free speech zone"), but by the fact that we are *actually influenced* by what we read on the iPhone. American politicians ought to be ashamed that their own messages are so weak and unreliable that a silly Facebook post (OK, lots of silly Facebook posts and Instagram photos) can change a person's mind.
