# BIG SOLAR POWER PLANT Coming to Northern Virginia

The solar energy company sPower is looking to build the largest solar power plant on the East Coast right here in Virginia. The plant will cost \$615 million and take up about 5 square miles of land in western Spotsylvania County.

It took two years of debate, but the local government has voted to create the special-use permit for the use of the "wilderness" area of Spotsylvania County. Ultimately, more than 1,000 construction jobs will be created to install about *two million* solar panels on the land.

If the land remained undeveloped, it would generate about \$700K in property taxes over the next 35 years. With this solar panel installation, that number balloons to about \$20 million in property taxes over the same amount of time.

Part of the plan is to sell energy to big tech companies like Apple and Microsoft, who already have a footprint in the area. With Amazon moving in, the demand will only increase.

While there are some environmental concerns (water and noise pollution), the county was satisfied with sPower's compromises, and it will be exciting to see the biggest solar power plant on the East Coast right here in the Commonwealth of Virginia!

## SUSIE'S JALAPEÑO CORN DIP


#### Ingredients:

- 1 cup mayonnaise
- 1/2 cup sour cream
- 3 (11oz) cans white shoe peg corn or Mexicorn blend, drained
- 2 (4oz) cans chopped jalapeño peppers (drained, save liquid to add to taste)
- 3 chopped green onions
- 2 cups shredded sharp cheddar cheese or cheese blend

#### **Directions:**

- 1 Mix mayonnaise and sour cream together.
- **2** Add drained corn, jalapeño peppers, green onion and cheese.
- **3** Chill 2 hours or overnight.
- **4** Serve with tortilla chips or Fritos scoops!

For a more mild flavor, substitute 8 oz. diced green chilies for the jalapeños.

# GOOGLE FOR SMALL BUSINESS?

Google is introducing a cool new service for small businesses. It's called CallJo, and it combining several technologies, including virtual phone numbers, audio transcriptions, automated reporting and analytics, in a new effort to help small business owners better manage their inbound phone calls. Google says that the system offers a low-cost customer service agent that helps block spam calls, provide callers with basic business information and redirects customers to complete their requests — like appointment booking or placing a to-go order — over SMS. It's priced at \$39 a month and might be what some small businesses are looking for.

Calls are recorded and transcribed, so that could help with marketing because you could see what your customers are asking for. The

downside? CallJo would be your main business number, and it's a fair amount of work to update all of your marketing properties to this new number, and if the system isn't all it is promised to be, it could be a disaster if you have to change back. Anyway, it might be worth looking at.
