# Memento Mori

About once a month, my family plays "would you rather" at the dinner table. The rules are simple: Everyone offers one question and then we go around the table answering the question. Would you rather vacation in Europe or South America? Would you rather be deaf or blind? Would you rather eat poop or dirt? (The six-year old's question almost always has something to do with the toilet.



The answers tell you a little bit about your kids and give you a veiled opportunity to teach a family value. (Ok, maybe not the question about poop).

The other night, the text chain for one of my mastermind groups asked: would you rather know **how** you're going to die or **when**?

The group was split, but my answer came easy: **When**. When offers peace and opportunity. How offers fear. What if you knew that you were going to die by a tree branch falling on your head? You'd never go outside for fear that it might be your last time.

Knowing when lets you plan. Going to die in three decades? You have time to work on building a strong foundation for your legacy. Going to die in three weeks? Better get your affairs in order, talk to your loved ones, and start scrambling to check off that bucket list.

Which got me thinking... since we don't know when we are going to die... and because it might be in three weeks... shouldn't we be living our lives with more urgency and intentionality? You wouldn't waste the afternoon watching football if you knew you only had 20 afternoons left, would you? Nor would you settle for a crappy meal!

The great American poet, Tim McGraw, wrote about this idea in his 2004 hit "Live Like You Were Dying," but the idea is much older. The Stoic philosophers used the phrase *Memento Mori*. "Remember that you will die." This reminder serves several purposes.

#### Memento Mori

It humbles. Some accounts of Roman victories include the role of an aide who would walk just behind the conquering general and whisper in his ear "Remember, thou art mortal."

It gives you reason to celebrate. One Egyptian festival custom was to bring a skeleton into the room: "eat, drink, and be merry! One day you'll be dead and look like this!"

It gives you something to reflect on. Marcus Aurelius, the most famous of the Stoic philosophers, wrote in his Meditations that "you could leave life right now. Let that determine what you do and say and think."

It inspires and challenges you to prioritize. If you only had a few weeks, what would you do? Make a list. Then challenge yourself to bring one of those bucket lists items off of your bucket list and go and do it in 2022.
