Local High Schools Have a Chance to Win \$1,000 from Ben

Ben has been a youth soccer referee since 1974, and much to our dismay, the state of sportsmanship from players, parents, and coaches is hitting a really rough patch. Earlier this year, the Washington Post ran an article stating that verbal abuse is causing a referee shortage in local youth sports.

Ben aims to fight back against this trend by awarding local high schools with up to \$1,000 (\$500 each for the boys' and girls' varsity teams) if they can make it through the spring season with ZERO yellow or red cards for unsportsmanlike conduct.

Here are the schools that are eligible: Fairfax HS, Lake Braddock Secondary, Robinson Secondary, South County HS, West Springfield HS, WT Woodson HS, Centreville HS, Chantilly HS, James Madison HS, Oakton HS, and Westfield HS.

This month, we are mailing a custom package to the principals, head coaches, athletic directors, and athletic booster clubs of each of these schools encouraging them to participate (hey, it's free money if they avoid the cards). If your school is on the list, definitely reach out and encourage them to take part. Youth athletics should be about healthy competition, not dissent and name calling.



It's not just about setting a good example for our kids; it's showing them that good behavior is rewarded in the real world, and that treating each other with respect is a cornerstone of our society. It would be a real shame for the referee shortage in our community to continue for such a petty and childish reason.

BGL's Best Bites GRANNY MARY'S CHOCOLATE PIE

From Tifiny Swedensky: In September 2017, my great-grandmother passed away. We were all sad to see her go, but happy that we got to spend so much time with her. In her will, she donated all her money to charity and left her grandchildren some of her heirlooms. I was fortunate to get her antique china cabinet.

Just before Christmas, the china cabinet arrived and, to my surprise, it still contained many of her possessions. One item in the china cabinet was a small, green aluminum box of notecards. On these notecards were her handwritten recipes that she collected during her life.

In this month's newsletter, I want to share with you her recipe for Chocolate Pie and her Cold Water Pie Crust. The instructions and ingredients are exactly as she wrote them, which is why she calls it an "ice box" instead of a refrigerator. I couldn't find her meringue recipe, so you'll have to look that one up on the internet.

Ingredients for Pie Crust:

- 3 cups flour
- ½ cup ice water
- 1 cup shortening
- 1 ½ tsp salt

Directions:

- 1 Cut shortening into flour and salt until thoroughly blended.
- 2 Add water. This recipe is sufficient for 2 (10 inch) pie crusts. The pastry can be placed into the ice box and used several days later if desired, or only ½ of the recipe may be used.



- 3 egg yolks
- 1 tablespoon cornstarch
- 1 oz chocolate
- 1 cup boiling water
- 1 cup sugar
- 1 teaspoon vanilla

Directions:

- 1 Mix cornstarch and sugar and add boiling water. Cook until thick.
- **2** Add chocolate, finely cut, egg yolk, and cook in double boiler until thick.
- **3** Add vanilla then pour into baked crust.
- **4** Cover with meringue and brown.
