Planet vs. Plastics

Eight years ago, I was finishing up my Associate's Degree in Paralegal Studies at Northern Virginia Community College. I got down to the last credit class required to graduate and was told I needed to take math or science, so I chose Environmental Science with a brilliant professor. I completely immersed

myself in the curriculum, labs, and field trips. I especially liked our visit to an apiary at George Mason University. It was an eye-opening experience on our world and every living creature that shares our planet.

The first Earth Day was held on April 22, 1970. By the end of 1970, that day led to the creation of the U.S. Environmental Protection Agency and successful laws like the Clean Air Act, Clean Water Act, and Endangered Species Act. The theme for this year is Planet vs. Plastics. Some facts:

- Americans purchase about 50 billion water bottles per year, averaging about 13 bottles per month for every person in the U.S.! That means by using a reusable water bottle, you could save an average of 156 plastic bottles annually.
- 2. When plastics end up in landfills, they aren't harmless. They break down into tiny toxic particles that contaminate the soil and waterways and enter the food chain when animals accidentally ingest them.

There are so many ways that you can help end plastic pollution, but I would suggest you start off with just one or two habits and then keep adding on as many as you can handle. Here are a

Strategic Thinking for Client Victories

Sometimes, choosing the right attorney means picking a team that not only specializes in what you need, but knows how to do it creatively.

We were fortunate to represent a very sweet family of three who were involved in a horrible crash. To make matters worse, there was very limited liability coverage available to the three of them. Luckily, two of them did not require a lot of additional medical care, but one of them was severely injured and had significant medical bills.

One of the things I love most about our office is our team-centered approach to cases. We meet weekly to review our numbers, review current cases, and discuss strategies to maximize the recovery for our clients. This case was one that involved a lot of active discussion. The liability carrier had tendered their small policy early in the case and, through creative brainstorming, we were able to distribute settlement funds in a unique way that maximized the family's final recovery. We did this by investigating all possible policies that may

be applicable – including underinsured motorist coverage for the most severely injured family member. We then made the strategic decision to give her a very minimal amount of the liability policy so that her father and daughter could receive a majority of those funds. This left her entire policy of underinsured motorist coverage available to her. I was so proud of our team for being creative and figuring out what was best for this family.

This unfortunately is not uncommon. We have a number of clients where the liability policy just isn't enough. So double check your policies and be sure to get as much coverage as you can. It really isn't much more to increase your limits to ensure you are protecting you and your family. If you ever have any questions about your coverage, please reach out to us so we can help.

Our Adoption Story

Last month Sandi and I went to see Steven Curtis Chapman perform in Arlington, Virginia. We first saw him perform on March 8, 2002, in a concert that changed our lives forever because it set off our adoption journey. Since then we have attended over a dozen Steven Curtis Chapman events, including an outdoor concert at a drive-in movie theatre during COVID.

In a recent talk at our church, Abiding Presence Lutheran Church in Burke, I shared the story of that journey, and how our family went from "four kids and a dog" to a large family of nine children.



THE CALL TO ADOPT

I initially resisted the call, feeling that we were "filled up, too busy, and not at all qualified" to adopt. The day after our first concert I told my pastor that "I think I've had a "God event" and I'm not sure where that's going to take us.

It took us to China, eighteen months later, for our first adoption trip to adopt Kevin.

ADOPTION AND TRANSFORMATION

Over the years, we made two additional adoption trips to China as we adopted Emma, Leah, and David. Leah and David were adopted on the same trip. Through this process, we initially believed we were answering a call to provide for God's children. However, as we navigated the new experience of raising children not born to us, we realized that these children were also changing us. Our journey forced us to reconsider everything we

thought we knew about parenting, communication, and love.

FUNDAMENTAL LESSONS LEARNED

Through our adoption journey, we learned three fundamental lessons that reshaped our approach to life and relationships:

- Understanding Fear and Shame:
 We realized that when people
 say or do things that irritate us,
 those behaviors are often driven
 by the very powerful emotions
 of fear and shame. Recognizing
 this taught us to approach, with
 empathy and understanding, our
 interactions with others today.
- Control Over Responses: Life is unpredictable and often out of our control. However, we have absolute dominion over our responses to life's challenges. This lesson, emphasized by our experiences with our children and those who have supported

us along this journey, has taught us the importance of controlling our responses to the



challenges of life. We believe that most of what we are called to do as children of God is wrapped up in the moment someone says or does something that irritates or disappoints us, and our response to that adversity.

• The Power of Healing
Conversations: Conflict is
inevitable, especially with those
closest to us. Our adoption
journey has underscored
the importance of healing
conversations, which must occur
when emotions have cooled. This
understanding has led us to value
the timing and energy required
for these discussions, challenging
the notion that conflicts must be
resolved immediately.

I was a very young trial attorney and this doctor, his lawyer and his "great" expert witness from UVA thought they would roll me. The jury heard the truth and awarded \$500,000, which was, at the time, one of the highest malpractice verdicts in Virginia.

Now comes the most interesting part: as we were leaving the court room that day, this doctor's assistant started screaming at me that "next time we'll just let her die." Two years later, when this assistant herself was the victim of malpractice, she called us to represent her.

We said "no thanks."

It's All a Matter of Attitude – and Staff!

My adjuster said to me, "Oh, this happened at your beach house? Must be nice."...which is how I knew I was going to shop for a new insurance carrier as soon as the claim was over.

If you're in insurance, someone is almost always calling you on a bad day. The same is true in most law firms. No one calls a personal injury lawyer (or a divorce lawyer, or a criminal defense lawyer) because something awesome happened to them.

Your team's attitude must reflect that while the client has been thrust involuntarily into our world, they've made an excellent decision by calling you. You cannot train and script for this. You have to build the right culture within your firm and then only hire great matches for that culture.

And here's the thing about running a small law firm...The most important hires often aren't lawyers.

They're your staff.

It doesn't matter how amazing your attorneys are if the staff...

- · Can't run an effective intake
- Can't get the medical records in and organized on time
- Isn't over-the-top empathetic to your clients



Most firms view lawyers as the value and the revenue drivers. After all, we craft the winning arguments. We have the Perry Mason moments. We know to stop before asking one question too many on cross.

And while all of that is important, it really is maybe 5-10% of what actually goes on in a law firm. And it's an even lower percentage of what makes up a great client experience.

My take: Hire the best staff you can find and take care of them.

Susie's Skillet-Roasted Carrots



I recently had a potential Long-Term Disability client tell me how much he missed our recipes in the newsletter. Far be it from me to disappoint a fan! I thought this recipe for skillet-roasted carrots was a great choice for a quick and easy spring side dish. The key is to use a rainbow carrot blend. The color really elevates the dish to the next level.



INGREDIENTS

1 Tbsp. olive oil

1 lb. rainbow carrots

1/2 tsp. kosher salt

1/4 tsp. black pepper

3 Tbsp. apple cider vinegar

2 Tbsp. honey

1 tsp. fresh thyme leaves

INSTRUCTIONS

Heat oil in a large skillet on medium-high. Add rainbow carrots, salt, and black pepper. Cook and stir until carrots are tender and browned in some areas (approx. 7 minutes). Add honey and vinegar and cook until liquid thickens and coats the carrots (approx. 1 minute). Sprinkle with fresh thyme and serve.
