Though three years have passed, I still talk about it often-not just because it took me to unimaginable places, but because it gave me the ability to really slow down and take in life. In a world overwhelmed by notifications and digital noise, SAS gave me the rare opportunity to unplug. At sea, I had about seven minutes of Wi-Fi a day-just enough to check in with loved ones. No endless notifications. No doomscrolling.

That disconnection made room for something deeper: real connection. Free from distractions, I found myself fully present with the people around me. The ship was home to more than just students—it welcomed lifelong learners (retirees, professionals on sabbatical), ship kids (children of faculty), gap year students, and recent grads. We shared meals with professors and traveled alongside their families, building bonds rarely found in traditional classrooms. Though I've now spent more time apart from those people than we ever spent together, those relationships remain some of the strongest in my life.

In addition, SAS is special because each voyage is unique, with each one having new faculty, ports of call, and travel experiences. During my voyage, I had the incredible opportunity of floating in the Dead Sea, sleeping under the stars in the Sahara Desert, and standing before the Taj Mahal. We attended classes while out at sea and applied what we learned in real time–like transiting the Suez Canal while discussing it in our Global Studies class.





Today, I'm writing this for anyone seeking something different. Whether you're a college-age student, a working professional ready for a bold new chapter, or retired and craving adventure, I urge you to look into **Semester at Sea**. It's more than a program– it's a community, a voyage, and a powerful way to see the world (and yourself)–differently.

And who knows? It might just become one of the best things you ever do. ■



Stepping Outside Your Genre


If you know me, you know I love fantasy and science fiction. I grew up devouring The Chronicles of Narnia, the Redwall series, Percy Jackson & the Olympians, and The Hobbit. On the sci-fi side, I've probably seen Star Wars more times than I can count, and I spent many nights with my grandfather watching classic Star Trek episodes and delightfully cheesy old sci-fi films.

In the world of science fiction, there's an important distinction between *soft* and *hard* sci-fi. Soft sci-fi leans more toward fantasy, often with minimal scientific grounding. *Star Wars* is a great example—The Force is basically space magic, not something you'll find in a physics textbook.

Hard science fiction, on the other hand, is rooted in real science. The technology might be futuristic, but it's still tethered to scientific possibility. Think of *The Martian* – the book that was adapted into a film starring Matt Damon, where his character gets stranded on Mars. Yes, we haven't sent anyone to Mars (yet), but everything in the story, from orbital mechanics to chemistry, is based on actual science. That's what makes it "hard" sci-fi.

Now, I'll admit: I've never considered myself particularly science-minded. So, I've usually stuck with the softer, more fantastical side of the genre. But recently, I picked up *The Three-Body Problem* by Liu Cixin—a hard sci-fi novel—and it completely surprised me.

The book centers on first contact with an alien civilization and the global consequences that follow. It dives deep into quantum physics, astrophysics,



and computer simulations—territory that normally would have had me falling asleep. But what kept me turning the pages was the compelling characters, rich philosophical questions, and unexpected twists and turns. The storytelling is wildly imaginative yet intellectually grounded, and it's easy to see why the book won the prestigious Hugo Award.

Even if you don't usually read science-heavy fiction, I'd encourage you to give *The Three-Body Problem* a try. Sometimes, stepping outside your usual genre can lead you to something unforgettable.
